THE MUSEUM GRANTS NO EXCLUSIVE RIGHTS TO ANY PUBLISHER, AUTHOR, OR PHOTOGRAPHER, AND ASSUSMES NO RESPONSIBILITY FOR DUPLICATIONS OF OBJECTS BY OTHERS NOR ANY RESPONSIBILITY FOR CLAIMS BY THIRD PARTIES, INCLUDING THE ARTIST, AUTHOR, ETC. PERMISSION WILL BE GRANTED SUBJECT TO THE FOREGOING CONDITIONS AND THE CONDITIONS BELOW.

Requests to reproduce an image shall be made in writing to the Rights and Reproductions Department of The Newark Museum of Art (the "Museum") stating the intended use, the title of the publication, the name and address of the publisher and the expected date of publication.

Reproduction is permitted only from materials supplied directly by the Museum. Permission to reproduce is given for one publication and one edition only. If subsequent reproduction of the object is desired, a new application must be submitted. Unless otherwise specified, the rights granted are limited to the United States. If material for which permission was granted is ultimately not used, the Museum must be notified.

Fee for photography and reproduction are payable upon presentation of the Museum invoice. Application's failure to pay such fees within 30 days of presentation shall constitute a materials breach of this agreement which, if not immediately cured, shall render the permission void and entitle the Museum to all available legal and equitable remedies.

Identification of the work and the full credit line, as supplied by the Museum, must appear in immediate proximity to the reproductions or in the section within the publication devoted to acknowledgments.

Proofs of all color reproductions must be approved by the Museum before publication.

Type or other matter may not be superimposed on reproductions of Museum objects. Museum materials may be reproduced in part only with the approval of the Museum and only if the caption indicates that a detail is being reproduced.

The Museum makes no warranties or representations and assumes no responsibility for any claims, royalties, or fees claimed by the artist, on his or her behalf, or by any other person claiming a copyright or other interest in the work being reproduced. The applicant agrees to indemnify the Museum and hold in harmless against any and all such claims, including copyright infringement claims, royalty or fee demands, and/or actions, including the cost thereof, arising from the applicant's reproduction of works of art in the Museum's collection.
